- Death Certificates
- Social Security numbers
- Medical Records and proof of immunizations
- Dental Records
- Proof of income for everyone in the family (pay-stubs, award letters from Family Independence Program (FIP) or Social Security, bank statements, court orders receipts and child support letters)
- Proof of residency (utility bill or credit card bill issued within 90 days)
- Proof of assets for everyone (bank statements, deed to house, title to car and burial plots)
- Any document proving that you are the "Caregiver" for the child
- Custody/Guardianship/Adoption Papers

Proper Child Safety Seat Use Chart

This chart is a quick guide on where to start your search. It is important to continue your research to learn about each seat you use.

Types of Car Seats at a Glance		
Age-Group	Type of Seat	General Guidelines
Infants and Toddlers	Rear-facing-only	All infants and toddlers should ride in a rear-facing seat until they reach the highest weight or height allowed by their car seat manufacturer. Most convertible seats have limits that will allow children to ride rear facing for two years or more.
	Rear-facing-convertible	
Toddlers and Preschoolers	Forward-facing convertible	Children who have outgrown the rear-facing weight or height limit for their convertible seat should use a forward-facing seat with a harness for as long as possible, up to the highest weight or height allowed by their car seat manufacturer. Many seats can accommodate children up to 65 pounds or more.
	Forward-facing with harness	
School-Aged Children	Booster	All children whose weight or height exceeds the forward-facing limit for their car safety seat should use a belt-positioning booster seat until the vehicle seat belt fits properly, typically when they have reached 4 feet 9 inches in height and are 8 through 12 years of age. All children younger than 13 years should ride in the back seat.
Older Children	Seat belts	When children are old enough and large enough for the vehicle seat belt to fit them correctly, they should always use lap and shoulder seat belts for the best protection. All children younger than 13 years should ride in the back seat.

SAFETY TIPS:

- Keep kids rear-facing for as long as possible.
- Make sure everyone in the car is buckled up.
- Keep the car seat straps snug.
- Do not start using a booster seat too soon and do not stop using a booster seat too soon.
- The center seat is generally the safest spot in the car for kids.
- After you install your child's car seat, have it checked by a trained technician.
- Remember car seats expire.
- Do not text or talk on the phone while driving.

Legal

Below are some different legal options.

INFORMAL KINSHIP

Informal kinship care includes relatives who take care of other family members children without a formal, legal arrangement. Parents maintain legal custody and rights of the children regardless of level of emotional and financial support.

ADOPTION

Adoption is the process of gaining permanent legal custody. Adoption ends all of the birth parents' rights and responsibilities, which means that birth parents cannot go to court later and reclaim those rights and responsibilities. This makes access to services on behalf of the child the same as for any parent.

POWER OF ATTORNEY

Signing a Power of Attorney, parents legally grant relatives the authority to raise the children, without the involvement of an attorney.

GUARDIANSHIP

Guardianship does not take away all the birth parents rights and responsibilities. However, Guardianship allows access to services on behalf of the child that otherwise might not happen without changing family relationships legally. Birth parents keep certain rights and the obligation to financially support the child. Unlike adoption, the birth-parents can go back to court and ask for the guardianship to be ended.

LEGAL CUSTODY

Custody is gaining legal rights and responsibility through a Family Court. Change in custody requires a formal hearing in the court.

Region 9 Area Agency on Aging Kinship Care Program

- Kinship Care is a program for relative care providers caring for related children. If you are age 55 or older and caring for a related child under the age of 18, this program may be able to help you with expenses such as recreational activities, school supplies, clothing, needed furniture and more. Funding is limited.
- Two requests per year may be made per child.
- There is a limit of \$300 per request.
- Some eligibility restrictions and limitations apply.

- Clothing

Northeast Michigan Community Service Agency (NEMCSA) Services

- **FOOD PROGRAMS:**

- *Golden Grocery Giveaway:* Is a monthly food distribution program and is designed to aid individuals aged 60+.

- **HEAT AND UTILITY ASSISTANCE PROGRAM**

- This program provides assistance to qualifying at-risk households for electricity and natural gas as well as delivery of fuel for a household's primary heat source either propane, fuel oil, or firewood.
- Interested applicants are screened for eligibility by calling 989.358.4713.

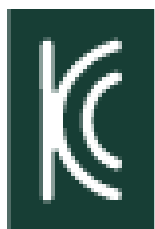
- **LOW-INCOME WEATHERIZATION PROGRAM**

- This program provides ceiling and attic insulation and ventilation, wall, floor, and perimeter insulation, caulking, weather-stripping, and other measures to prevent air infiltration.
- Interested applicants are screened for eligibility by calling 989.358.4714.

- **EARLY CHILDHOOD EDUCATION PROGRAMS**

- *Early Head Start:* Serves pregnant women and children birth to three years of age and their families. The program provides intensive and comprehensive child development and early education services including health, nutrition, and family support services.
- *Head Start:* This is a school-readiness preschool program for children 3 - 5 years of age whose family incomes are at or below 100% of poverty.
- *The Great Start Readiness Program:* Provides many of the same services as Head Start with the exception that eligibility is limited to 4 years of age and is open to families whose incomes are within 250% of poverty.

resource center

The Kinship Care Resource Center connects kinship families to the resources, tools, and networks that support them. We've made it our mission to support and empower kinship families across Michigan to ensure the children they are raising are safe, healthy, nurtured and loved.

The Kinship Care Resource Center is pleased to offer the following services for current and prospective relatives caring for relative children:

Coordination of Care: Helping service provider networks that engage with kinship families collaborate, connect, and coordinate with one another alongside and on behalf of kinship caregivers and the children in their care.

Communication, Technology, and Information Sharing: Using newsletters, a website, a toll-free phone line, and social media to share resources and provide support for kinship families.

Kinship Navigators: Connecting trained Kinship Navigators, who have experienced kinship caregivers, to other kinship caregivers through phone consultation and community outreach.

Group Services: Providing a calendar of support groups offered throughout the State of Michigan, assessing where the need for new or more groups exists, and support group implementation.

Financial Help

There are two types of Family Independence Program (FIP) Grants:

- 1. Ineligible Grantee Awards (Child Only Grants)** are available for the child regardless of household income. A foster child's income (Supplemental Security Income [SSI], Retirement, Survivors, and Disability Insurance [RSDI], etc.) is not included in the household income and will reduce the award amount.
- 2. Eligible Grantee Awards (Family Grants)** are based on the income and assets of all family members. To remain eligible, relative caregivers must work unless they provide proof of disability or are older than 65 years old.

How do I apply for the Family Independence Program (FIP)?

The Assistance Application, DHS-1171 is available at local MDHHS offices or you can apply online at www.michigan.gov/mibridges.

How will I get Medical Care for the Child?

If children do not have medical coverage through a private insurance, they will be covered by Medicaid.

CHILD ONLY GRANT

- The Child Only Grant is not through MDHHS.
- The Child Only Grant is available for children who are being raised by a relative who is not a biological parent.
- This financial assistance is based on the child's income and assets; not the caregiver's.

The Michigan Department of Health and Human Services (MDHHS) has multiple assistance programs that exist to help individuals in need. MDHHS provides cash assistance, food assistance, child care assistance, and medical assistance to eligible individuals. Eligibility is based on need/income level for the majority of these programs.
