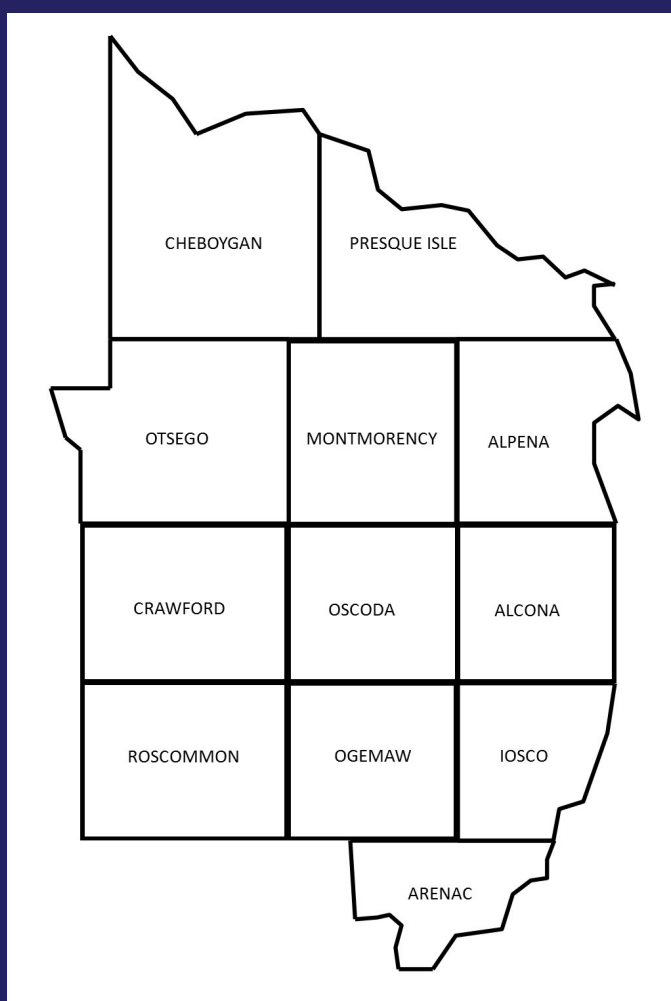

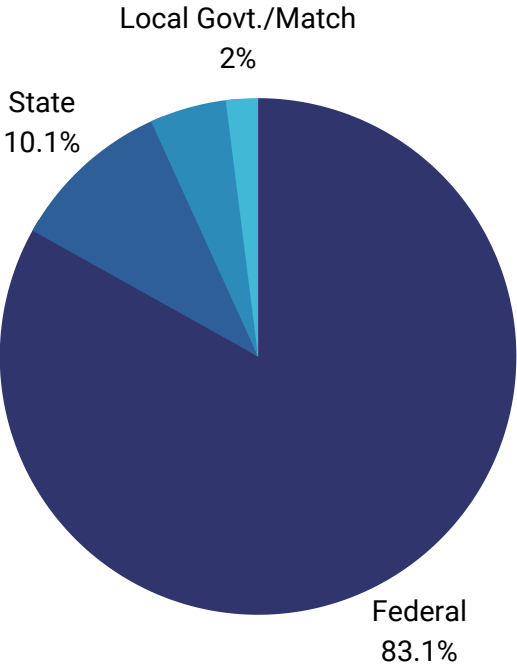
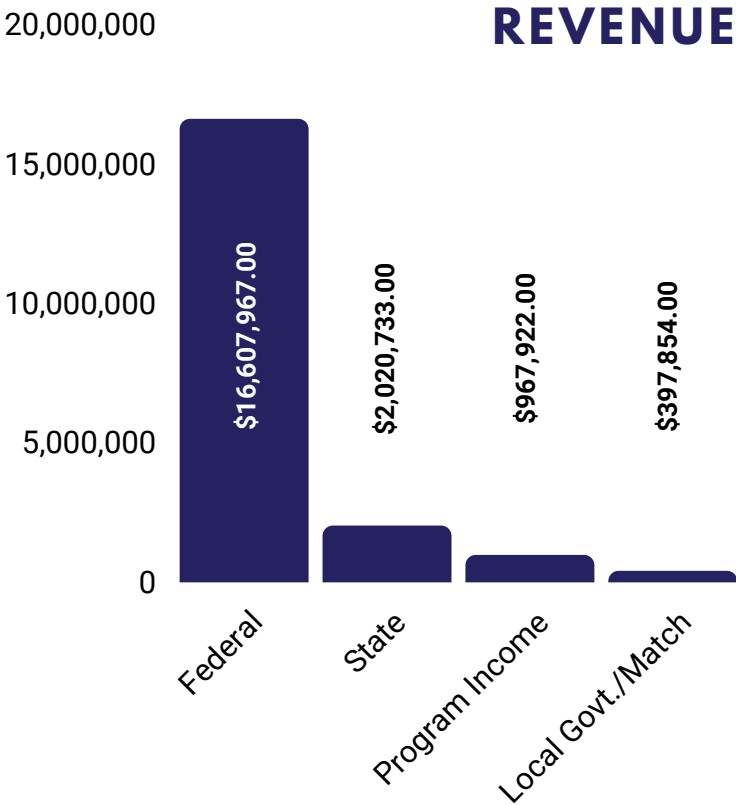

The AAA assisted with distributing large quantities of PPE to our local partners, including 34,962 masks, 338 disinfecting wipes, 26 gallons of hand sanitizer, 14 thermometers, and 606 face shields.

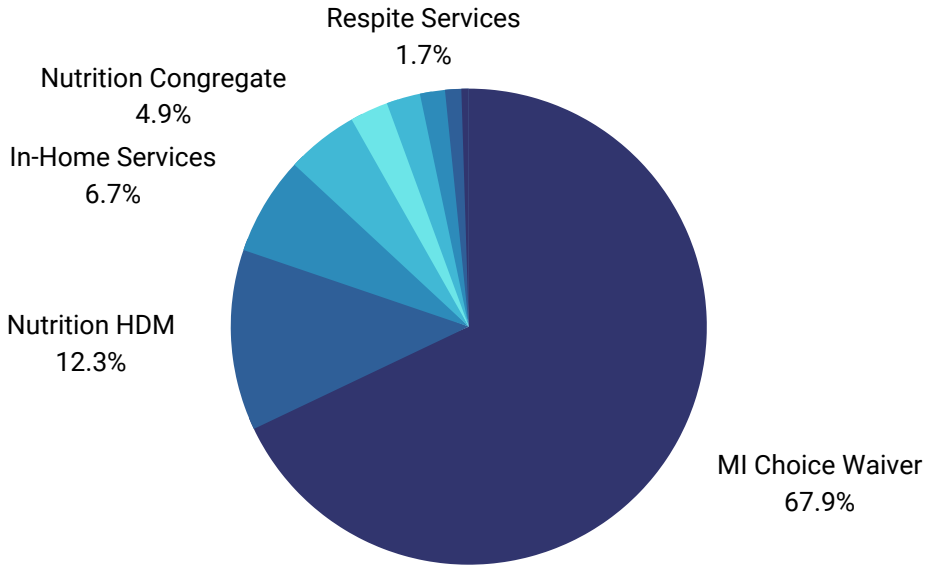
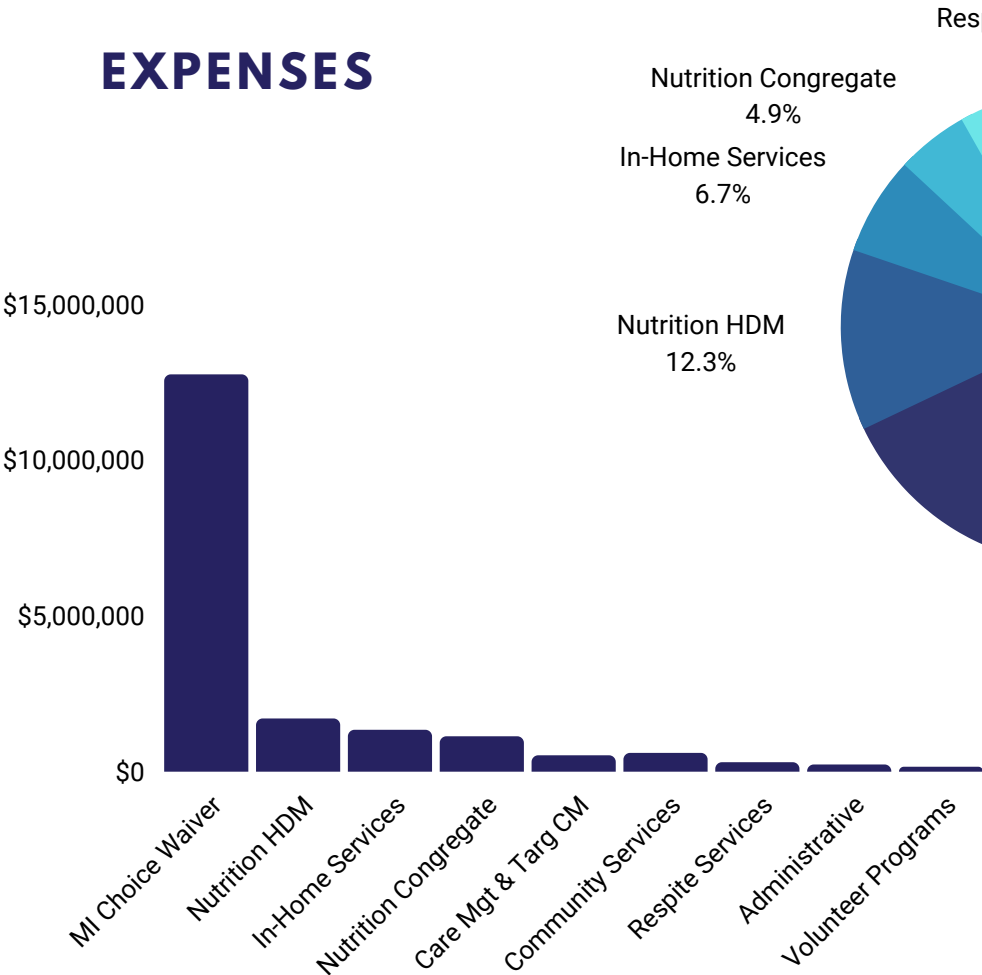
